**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chow Lajamang Mannow, Village Nanam Khamti, P.O. Manmow, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE( PWD ), Govt. of A.P., Anini Division, Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 07/03/2025 regarding Infrastructure Development for SIB at Anini, Dibang Valley District, Arunachal Pradesh.
- 2). **The 1<sup>st</sup> hearing was held on 16<sup>th</sup> September' 2025.** Shri Binam Messar, PIO-cum-EE ( PWD ), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh attended the court through Video Conferencing. The Appellant Chow Lajamang Mannow was present in person.
- 3). The PIO submitted that they had received RTI application of the Appellant on 19<sup>th</sup> March'2025 and on 16<sup>th</sup> April'2025 acknowledged the receipt and asked the Appellant to deposit an amount of Rs. 858/- (Rupees Eight Hundred Fifty Eight) only being charges for the supply of information through Challan but no response was received from the Appellant.
- 4). The Appellant informed the Commission that he had not received any letter from the PIO.
- 5). The Commission directed the PIO to furnish information through the fastest means of communication, viz. WhatsApp, E-mail, etc. However, if the Appellant needed information in hard copies, the Appellant was advised to visit office of the PIO and collect the same. In case information were not available, the PIO was directed to give justifiable reasons in writing through AFFIDAVIT. Since the prescribed time limit had lapsed, the PIO was directed to furnish information free of cost to the Appellant.

6). The Appellant was directed to collect information from the PIO within 15 (fifteen) days from the date of issue of the order dated 16<sup>th</sup> September'2025. The Appellant was also directed to intimate the Commission in writing, with a caution that in case he failed to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.

7). Till date the Appellant has not given any intimation to the Commission and therefore, in view of the order dated 16<sup>th</sup> September'2025 the Commission decides to dispose of the case.

8). Therefore, the case is hereby disposed of.
