Information sought :

The appellant file an RTI Application dated 14/10/2024 seeking Details regarding Upgradation of road from Pare-ami to Dilopolyang to intermediate lane at Ziro, Lower Subansiri District A.P. (length 8.50 km).

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 18/11/2024. The First Appellate Authority has not conducted the hearing in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte **09/10/2024** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Ziro Division, Lower Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on

18/11/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.03.2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 246/A/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2(two) times i.e. on 03/09/2025 and 03/11/2025. In this hearing of the appeal on 3rd day of November, 2025, the PIO-cum-EE (PWD), Ziro Division, Lower subansiri District is represented by Er. Hibu Tada, JE but the appellant Shri Tamchi Gungte found absent without any intimation to then Commission.

As per the case record, during hearing at First Appellate Authority all the available documents sought by the appellant was brought to furnish to the appellant but due to his absence the documents sought could not be handed over to the appellant. On the first hearing dated 03/09/2025 the PIO has brought all the documents sought by the appellant but due to his absence the document could not be handed over to him.

Today again the PIO has brought all the sought documents and again the appellant is found absent. The appellant was directed to collect the information from the office of PIO and to intimate to the Commission immediately. If no intimation is made, the Commission will presume that the information sought by him has been provided and satisfied.

But till date no any intimation has been received from the appellant. Therefore, the Commission presumes that the appellant is no more interested to pursue this appeal case.

Therefore, this appeal case No. APIC-246/A/2025 is disposed of and closed in his absence.
