FACTS OF THE CASE:

The appellant filed an RTI application dated **20.03.2023** seeking information pertaining to construction of Halaipani SHEP and maintenance of various hydels under HPD Hayuliang. The PIO did not furnish any reply to the RTI application. The appellant then field a first Appeal dated **21.04.2023**. First Appellate Authority's (FAA) order, if any, is not available on record. Feeling aggrieved, the appellant approached the commission with the instant second Appeal.

After receipt of the second Appeal notices were issued to the parties to appear on 01.09.2023

The appellant appeared on 01.09.2023 and submitted that the PIO did not provide reply in response to his RTI application. The PIO who was also present during the hearing, submitted that Halai Pani SHEP in Hayuliang, constructed way back in 2001-02, was damaged by flood water few years back and no budget provision had been kept for its maintenance or restoration. He has also clarified that fund provision of RS 500 Lakhs kept in BE, 2022-23 is only for clearing pending liabilities. He however agreed to finish relevant information / documents as per available record. The commission after hearing both parties

directed the PIO to furnish correct and complete information as per available record within a period of 2 weeks and send compliance report to the commission. The commission adjourned the case to 03.11.2023.

DECISION:

None appears before the commission. However, the commission has received a letter dated 21.09.2023 from the appellant wherein he has informed that PIO has furnished complete information and expressed satisfaction regarding information furnished by the PIO. Keeping in view the facts of the case and the written submissions received from the appellant, the commission is of the opinion that complete information, though late, has been provided by the respondent PIO. The appellant has also showed satisfaction with the information provided. Hence, no further intervention of the commission is required in the matter. The instant appeal stands **disposed of accordingly.**
