This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Gangte Takuk, Leel, PO/PS Sangram, Kurung Kumey District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P. o/o of Deputy Commissioner Changlang, District Changlang, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/06/2025 regarding c/o 20 beds Hostel Building including Kitchen & Dining Hall with warden room.
- 2). The 1st hearing was held on 3rd February' 2026. The PIO-cum-EE (RWD), Govt. of A.P. Rural Works Department Laaying Yangte Division, Kurung Kumey District, Arunachal Pradesh had been represented by Shri Yangbiu Lika, APIO-cum-AE (RWD), Laaying Yangte. The Appellant Shri Gangte Tatuk was present.
- 3). The APIO had informed the Commission that the information sought by the Appellant were regarding on ongoing project. However, the APIO had assured to furnish available information to the Appellant. The PIO was directed to furnish available information within 24th February 2026.
- 4). The Commission had directed the Appellant to contact the PIO, visit the office, and get information. After receipt of the information, the Appellant was asked to intimate the Commission in writing, his satisfaction or dissatisfaction within ten days from the 24th February 2026 but the Appellant failed to do so.
- 5). The Commission in view of the Order dated 3rd February 2026 decided to dispose of the case.
- 6). Therefore, the case is hereby disposed of.
