**Information sought :**

The appellant file a RTI Application dated 28/06/2025 seeking Details regarding Appointment order, place of posting, approval from competent authority., advertisement details, present strength, new strength etc. of W/C staff under the Sub-Division.

As per the case record, PIO did not provide the sought information.

Being dissatisfied, the appellant filed First Appeal dated 13/10/2025. First Appellate Authority had conducted hearing in his jurisdiction on 06/11/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ashok Sangbia on **28.06.2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Power), Sagalee Electrical Division, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **13.10.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **20.11.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 863/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 03/06/2026. In this hearing of the appeal on **3<sup>rd</sup> day of June, 2026**, the PIO-cum-EE (Power), Sagalee Electrical Division present in person but the appellant Shri Ashok Sangbia found absent, however, sent a letter addressed to the Commission requesting to dispose of the appeal case No. APIC-863/A/2025.

Request accepted and the appeal case is disposed of and closed.
