**ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Sangha Radhe on **8/8/2023**, filed an RTI application under Form-'A' before the PIO-Cum-EE (PHE&WS) Division of Koloriang, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **13/10/2023**, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **4/12/2023** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 1125/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission four times i.e on **28/11/2024, 11/02/2025, 17/04/2025 & 3/07/2025**, details of information(s) sought from the PIO.

- i) Certified true copy of sanction order copy
- ii) Certify true copy of DPR copy
- iii) Certify true copy of approval copy
- iv) Certify true copy of NIT publish in local news daily's in colour.
- v) Certify true copy total numbers of Firm participated during tender competition.
- vi) Certify true copy of the winning Firm.
- vii) Certify true copy of total numbers of household in Patuk, Rapuk and Toko village.
- viii) Certify true copy of total numbers of population exists in Patuk, Rapuk and Toko Villages.
- ix) Certify true copy village for no issued by the concern authorities in respect of Patuk, Rapuk and Toko village.
- x) Certify true copy of acceptance of letter issued by Division Executive Engineer to the wining Firm for Execution of work.
- xi) Certify true copy of agreement between Department and Implementation agency.
- xii) Certify true copy of Cheuque Counterfoils if the bill is released.
- xiii) Certify true copy of non-duplicacy certificate issued by Executive Engineer c concern.
- xiv) Certify true copy of work progress reports and completion reports.
- xv) Certify true copy of all existing members Adhar Card of Patuk, Rapuk and Toko Village.

In the final hearing on **3<sup>rd</sup> day July 2025**, the PIO and Appellant both are found absent during the hearing.

However, the Appellant Shri Sangha Radhe, has submitted a letter to the Commission on **2/7/2025**, stating that he has received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
