### JUDGEMENT ORDER

-V/S-

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Riya Taram & Shri Takam Sakap, C/O Moina Shop, Near Futsal Ground Lekhi, Naharlagun, Arunachal Pradesh, for non-furnishing of information, by the PIO–cum-EE, PHE & WS Daporijo Division, Upper Subansiri District, Govt. of Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 15.11.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

### "To furnish all the relevant documents against

#### A. Maintenance (revenue sector) HA-2215 WS and Sanitation Minor Works

- 1. Maintenance of Water Supply Schemes under Daporijo Division
- 2. Maintenance of Water Supply Schemes under Daporijo Division (SADA) Non-Plan
- B. 2215- WS & Sanitation OC
  - 1. Maintenance of Water Supply Schemes under Daporijo Division
  - 2. Maintenance of Water Supply Schemes under Daporijo Division (NRDWSP)
  - Maintenance of Water Supply Schemes under Daporijo Division (non-plan) SPA/ACA & SIDF etc.,
- C. Maintenance of Water Supply Schemes under Daporijo Division against Natural Calamities for the year 2010 to 2016 ".

### The above subject has been mentioned in detail under 'Form - A'.

The 1<sup>st</sup> hearing for the case was held on the 01<sup>st</sup> day of March'2023. The appellant was present. The representative of the PIO, Er. Khyoda Sanjay (JE, PHE&WS) was also present. After hearing both the parties, the representative of the PIO had informed the Court that he would submit the information as sought by the appellant as per his form-A on or before the next date of hearing of this case fixed on the 26<sup>th</sup> day of April'2023.

The 2<sup>nd</sup> hearing of this case was held on the 26<sup>th</sup> day of April'2023. The appellant was present. The representative of the PIO, Er. Khyoda Sanjay (JE, PHE&WS) was also present. After hearing both the parties, the representative of the PIO had informed the Court that the information as sought by the appellant was voluminous. Therefore, he pleaded for more time for furnishing the documents. As such, the Court fixed the next date of hearing of this case on 07<sup>th</sup> day of June'2023.

The 3<sup>rd</sup> hearing of this case was held on the 07<sup>th</sup> day of June'2023. The appellant was present but the PIO was absent. The Court/Commission seriously viewed the absence of the PIO without any intimation and diligently not performing his statuary duty and issued a Show Cause Notice for his personal appearance in the Court on the next date of hearing of this case fixed on the 28<sup>th</sup> day of June'2023.

The 4<sup>th</sup> hearing of this case was held on the 28<sup>th</sup> day of June'2023. The appellant was present. The representative of the PIO, Er. Khyoda Sanjay (JE, PHE&WS) was also present. After hearing both the parties, the representative of the PIO had again sought some more time to furnish the information on which the Commission viewed seriously of the repeated excuses from the PIO-cum-EE, PHE&WS Daporijo Division, Upper Subansiri District which established prima-facie evidence of violation of Sub-Section 01 of the Section 07 of the RTI Act,2005 by the PIO, in spite of repeated directions given by the Commission to the PIO in every hearing for furnishing information to the appellant but the PIO had failed to furnish the same in the 4<sup>th</sup> hearing. Therefore, a penalty amounting to Rs. 25,000/- was imposed upon against the PIO. Also, the PIO was also directed to furnish the information as sought by the appellant on or before the next date of hearing of this case fixed on the 26<sup>th</sup> day of July'2023.

The 5<sup>th</sup> hearing of this case was held on the 26<sup>th</sup> day of July'2023. Both the parties were present. After hearing both the parties, information sought by the appellant was furnished by the PIO during the Court proceedings itself. The appellant is directed to go through the same and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on the 23<sup>rd</sup> day of August'2023.

The 6<sup>th</sup> hearing of this case was held on the 23<sup>rd</sup> day of August'2023. The appellant was present. The representative of the PIO, Er. Khyoda Sanjay (JE, PHE&WS) was also present. After hearing both the parties, the appellant informed the Court that the information provided by the PIO in its previous hearing was incomplete/unsatisfactory. The representative of the PIO had been directed by the Court to sworn in affidavit of Non-Traceable/Non-Available on or before the next date of hearing of this case held on 13<sup>th</sup> day of September'2023.

The 7<sup>th</sup> hearing of this case was held on the 13<sup>th</sup> day of September'2023. The appellant was present. The representative of the PIO, Er. Hillang Raj (JE, PHE&WS) was also present. After hearing both the parties, the appellant was directed by the Court to provide the lists of left-out/additional information/documents to the PIO. the same should be provided by the PIO on or before the next date of hearing of this case fixed on the 18<sup>th</sup> October'2023.

The 8<sup>th</sup> hearing of this case held on the 18<sup>th</sup> day of October'2023. The appellant was present. The representative of the PIO, Er. Khyoda Sanjay (JE, PHE&WS) was also present. After hearing both the parties, the representative of the PIO had submitted a sworn in affidavit during the hearing of this case. Hence the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
