### JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Chow Wonnaseng Longphoi, Namsai, Namsai District, Arunachal Pradesh**, for non-furnishing of information, by **The PIO-cum-Executive Engineer, Rural Works Department, Namsai Division, Namsai District, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 09.09.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

***"Total fund sanction/allocation for the maintenance and construction of PMGSY road for the Namsai District"***.

The above subject has been mentioned in detail under 'Form - A'.

The 1<sup>st</sup> hearing was held on 08<sup>th</sup> day of February' 2023. The appellant was present but the PIO was absent. The PIO was heard over phone and informed the Court that he had already written a letter to the appellant to collect the documents from the PIO's Office. As such, the Court directed the appellant to collect the documents from the Office of the PIO and fixed another date of hearing for the case on 01<sup>st</sup> March' 2023.

The 2<sup>nd</sup> hearing was held on 01<sup>st</sup> day of March' 2023. Both the parties were present. Heard both the parties. The appellant expressed his satisfaction for all the documents received and later pleaded before the Court to dispose of the case. Hence, the Court directed to dispose of the case and no such hearings for the case will be entertained further in the Commission's Court.

***Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.***
