Information sought :

The appellant filed an RTI Application dated 27/02/2025 seeking Details regarding C/o 2 bedded Hostel including Kitchen & Dining Hall with warden room and C/o 4 unit Type-II quarters (G+1) at GUPS Ngopok.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 26/04/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Thomas Tayeng absent.
Respondent : PIO-cum-EE (RWD), Pasighat Division is represented by Er. Oyik Tabin, JE.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Thomas Tayeng on **24/03/2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (RWD), Pasighat Division, East Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the

information received from the PIO, filed the First Appeal before the First Appellate Authority on **26/04/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **22/05/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 458/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 09/02/2026 and 18/05/2026 In this hearing of the appeal on 18th day of May, 2026, PIO-cum-Executive Engineer (RWD), Pasighat Division is represented by Er. Oyik Tabin, JE but the appellant Shri Thomas Tayeng found absent without any intimation to the Commission.

As per the last order dated 09/02/2026 PIO stated that all the information sought by the appellant has already been provided except Sl. No. 6 (c) of the Form 'A'. PIO was directed to furnish the remaining information within 30 (thirty) days from the order. Today the PIO stated that the information is already provided which has been received by the appellant. Receipt copy of the same is submitted before the Commission today.

Appellant was directed to intimate to the Commission on receipt of the document otherwise the Commission will presume that the appellant has received all the information and satisfied.

Today the appellant is absent without any intimation. The Commission presumes that the appellant has received all the information and is satisfied.

Therefore, the appeal case is disposed of and closed.
