JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Doge Riba, C/O D.D Studio Building, Vivek Vihar, College Road, Itanagar, Papumpare District, Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum- Administrative Officer, O/o The Director APEDA, Urja Bhawan, Tadar Tang Marg, Itanagar, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 16.02.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“To furnish the details of information for Total Sanction post of Junior Engineer (civil), Surveyor, Draughtsman Grade-ii, Draughtsman Grade-iii and Technician-cum-Plant Operator and Eight (8) other Subject matters mentioned as per his Form-A.”

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 09th day of August' 2023. Appellant was absent but the PIO was present. The case was heard ex-parte. The information sought by the appellant has been kept ready and communicated to the appellant to collect the same from the PIO's office but the appellant has not turned up to collect the information as verbally informed by the PIO in today's hearing. Therefore, the appellant is hereby directed to collect the information from the PIO's office and after going through the same should inform his satisfaction or dissatisfaction on or before the next date of hearing of this case fixed on 30th day of August'2023.

The 2nd hearing for the case was held on 30th day of August'2023. Appellant was present but the PIO was absent. The case was heard ex-parte. The appellant has been directed to approach the PIO's office to collect the information which is kept ready by the PIO as informed in the previous hearing. After going through the same he should inform his satisfaction/dissatisfaction on or before the next date of hearing fixed on 14th day of September' 2023.

The 3rd hearing for the case was held on 14th day of September'2023. Both the parties were absent. The case could not be heard. The appellant was found absent for two consecutive hearings of this case. It is presumed that he is not willing to pursue this case further as he was directed to approach the PIO's office to collect the documents and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case i.e., today. Hence, the court decided to dispose of the case.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
