**Information sought :**

The appellant file an RTI Application dated 30/09/2024 seeking Details regarding Creation of CA Plantation in the construction of 2880 MW Dibang Multipurpose Projects by NHPC (2022-23).

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 11/10/2024. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Tamchi Gungte found absent.

Respondent : PIO-cum-DFO, Likabali Forest Division absent.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte 30/09/2024 filed an RTI application under Form-'A' before the PIO-cum-Divisional Forest Officer, Likabali Forest

Division, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 11/10/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.03.2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 202/A/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3(three) times i.e on 19/11/2025, 28/01/2026 and 20/05/2026. In this hearing of the appeal on 20<sup>th</sup> day of May, 2026, both the parties PIO-cum-DFO, Likabali Forest Division, Lower Siang District and the appellant Shri Tamchi Gungte found absent. However, the appellant has written a letter addressed to the Commission requesting to dispose of the appeal case No. APIC-202/A/2026 and 203/A/2025.

Request accepted and the appeal case is disposed of and closed..
