JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Pauwang Wangsa on 16.12.2022 filed an RTI application under Form-'A' before the PIO-cum- EE, UD & Housing Department, Longding District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 28.02.2023 Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.04.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 324/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 4 (four) times i.e. on 05.06.2023, 24.07.2023, 09.10.2023 & 29.11.2023. In this hearing of the appeal on 29th day of November,2023. The appellant Shri Pauwang Wangsa & the PIO present during the hearing.**

Heard both the parties.

The appellant intimated to the Commission during the hearing that, he has received all the information as sought by him in his Form-' A' application but he has some doubts regarding the information furnished by the PIO, So, the PIO explained the matter that he has furnished all the required information as sought by him in his application.

The Commission also asked the appellant if he is not satisfied and required the information in affidavit for his satisfaction, he may request to the PIO to furnish in a affidavit. On this, the appellant replied to the Commission that he does not need the information in affidavit, he is satisfied with the reason explained by the PIO to him and requested for disposal/closer of his appeal on the ground of satisfactorily receipt of all the information sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed for once for all.
