**Information sought :**

The Complaint filed an RTI Application dated 06/10/2025 seeking Details regarding C/o Road from ADC HQ Tali to Tani village.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 07/11/2025. No hearing has been conducted by the First Appellate in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Complainant Shri Donik Roru on **06/10/2025** filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Tali Division, Kra- Daddi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from

the PIO, filed the First Appeal before the First Appellate Authority on **07/11/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29/01/2026** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 167/A//2026** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 26/08/2026. In this hearing of the appeal on **26<sup>th</sup> day of August, 2026**, Appellant shri Dorik Roru present in person in person but the PIO-cum-EE(PWD), Tali Division found absent without any intimation.

Appellant Shri Donik Roru has submitted a letter addressed to the Registrar, State Information Commission, Itanagar stating that all the sought information has been provided by the PIO and is satisfied by the information provided and requested to dispose of the appeal case.

Request accepted and the appeal case is disposed of and closed.
