ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Taguk Dada, Polo Colony, Naharlagun, PO/PS Naharlagun, District Papum Pare, Arunachal Pradesh for non-furnishing of information by the State Public Information Officer (SPIO), Govt. of A.P. o/o UD & Housing, Jairampur Division, Changlang, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 31/03/2023 regarding various constructions and schemes under Budget Estimate 2022-23 and Revised Estimate 2022-23.

The 2nd hearing is held today on 16th January' 2024 (Tuesday) at 1030 hrs, the PIO is represented by Shri Katan Komut, ASW-Cum-APIO, O/o the UD & Housing, Jairampur Division, Changlang. The Appellant Shri Taguk Dada is found absent. During the 1st hearing held on 31st October' 2024 (Tuesday) at 1030 hrs, the APIO informed the Commission that on receipt of the form "A" application of the Appellant, the PIO has sought certain clarification about the BPL Card from the information seeker through postal services. It has also informed that if the Appellant make clarification on the matter, the information sought are kept ready in the Office of the PIO. The Appellant is not responded till date. And today i.e on 16/01/2024 during 2nd hearing the Appellant is found absent again. During 1st hearing it was directed both the parties to appear before the court in person in the next date of hearing without fail. If the PIO found absent the Commission shall initiate penal action under section 20(1) of the RTI Act, 20005and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

On the above conditions, an opportunity was given to the Appellant and in spite of giving warning, the Appellant skips the court hearing. Therefore, the case is disposed of with the directions to the PIO to furnish the information if the Appellant clarifies the queries made by the PIO

Hence, case is disposed of and closed.
