**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Riya Taram, Riang Store near Catholic Church, Jollang, PO/PS Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-Executive Engineer, Miao Electrical Division, Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/08/2025 regarding the work carried out under the Funding Head of Accounts 4801- Maintenance of ASSETS for the year 2022-23.
- 2). **The 1<sup>st</sup> hearing was held on 17th February' 2026 as scheduled.** The PIO-cum-Executive Engineer, Miao Electrical Division, Changlang District, Arunachal Pradesh was represented by Er. Mintu Phuntso, APIO-cum-Assistant Engineer, Miao Electrical Division. The Appellant Adv. Riya Taram was found absent.
- 3). The APIO informed that the information were prepared and the Appellant was asked to deposit Rs. 1324/- (Rupees One Thousand Three Hundred Twenty Four) only @ Rs. 2/- per page as fee through E-Challan in favour of Executive Engineer (E), Miao Electrical Division being the charges of 662 nos paper information. However, the Appellant did not turn up to pay the charges and collect the information.
- 4). Since, the Appellant was found absent without any intimation to the Commission, the Commission decided to dispose of the case as per caution issued vide hearing notice dated 16<sup>th</sup> January'2026.

Therefore, the case is hereby disposed of.
