ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-2 School, Itanagar Chimpu, Papumpare Distt. Arunachal Pradesh for non-furnishing of information by the PIO-cum-Directorate of Animal Husbandry & Dairy Development, Nirjuli Papumpare Distt. Govt. of Arunachal Pradesh, as sought for by the Appellant under section 6(1) of RTI Act, 2005 on 20/07/2022 regarding C/o National Livestock Mission (NLM) in the state of Arunachal Pradesh Year 2020-21,2021-22, 2022-23.

The 4th hearing is held today on 17th October, 2023 as scheduled. During the hearing Dr. S. Yomdo, the SPIO-Cum-Directorate (AH & DD), Govt. of A.P., Department of Animal Husbandry & Dairy Development Nirjuli, Papumpare District, Arunachal Pradesh alone is present. The Appellant Shri Tamchi Gungte is found absent. The SPIO has reiterated that on receipt of the Treasury Challan being the fee of the information, the SPIO has furnished all relevant information on 15/05/2023 through postal services. The Appellant is found absent during the 3rd hearing. During the 3rd hearing both the parties were directed to appear in person before the court of the Commission. Failing to comply with the directions the SPIO shall be imposed with penalty under section 20 (1) of the RTI Act 2005. It was also directed to the Appellant to be present in person failure to which the case will be disposed of without further notice. The Appellant is found absent and as per the submission of the SPIO, he has furnished all information on 15th May' 2023, the Commission is of the opinion that there is no need of any further proceedings to initiate for this case.

Hence, the case is disposed of, presuming that the Appellant is fully satisfied with the information so furnished.

Therefore, the case is disposed of and closed.
