JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Taro Mosing, Jollang, PO- RKM, PS-Itanagar, ICR, Arunachal Pradesh**, for non-furnishing of information, by **The PIO-cum-Jt. Director, Elementary Education, Judicial/Academic/Nodal Officer (POSHAN), Itanagar, Itanagar Capital Region, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 03.11.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding :

"Reg. Funding from State Govt. to Director of Elementary Education 2021-22 for Schools Upgradation in entire Arunachal Pradesh."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on 07th day of June' 2023. The appellant was present but the PIO absent. The APIO represented on-behalf of the PIO. Heard both the parties. The information sought by the appellant has been furnished by the APIO. The appellant received the same and was directed by the Court to go through the documents received and inform his satisfaction/dissatisfaction on or before next date of hearing fixed on 28th June' 2023.

The 2nd hearing for the case was heard on 28th day of June' 2023. The appellant was absent but the PIO was present. The case was heard ex-parte. Since the appellant was absent the matter couldn't be discussed further. As such, the Court fixed another date of hearing for the case on 26th July' 2023.

The 3rd hearing for the case was heard on 26th day of July' 2023. The appellant was absent but the PIO was present. The case was heard ex-parte. Since the appellant was absent for two consecutive times without any intimation to the Court for the reason behind his absence and hadn't responded to the multiple summons of the Commission. In view of this, the Court assumed that the appellant is no more interested in the case and directed to dispose of the case. Hence, the case is disposed of and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
