ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P. O/o BDO Mengio CD Block, Papum Pare District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 30/01/2023 regarding expenditure & implementation under MG-NREGA/ Supply work / Pending work / New work / Sanction order/ Compete work.

The 2nd hearing is held on 17th October, 2023 as scheduled. The SPIO-cum-BDO, Govt. of A.P. O/o BDO Mengio CD Block, Papum Pare District, Arunachal Pradesh is represented by Shri Nabam Tony, EO (RE) CD Block Mengio and the Appellant Shri Tania June is absent. The PIO submitted that the information sought for as per the directions of the Commission are ready to furnish the Appellant. But the Appellant has not collected the information till date. The SPIO is directed to furnish the information as and when the Appellant visits his office if possible he may furnish the information personally at Itanagar. The Appellant is found absent. During the last hearing he was directed to visit office of the SPIO and collect the information free of cost, and was also directed to be present during the next hearing. Failing to which the case shall be disposed of without further notice. The case is disposed of and closed presuming that the Appellant is no more interested in seeking the information.

Therefore, the case is disposed of and closed.
