FACTS OF THE CASE:

The appellant filed an RTI application dated 19.04.2023 seeking information on the projects/works sanctioned under Article 275 (1) of the constitution of India, by the Ministry of Tribal Affairs, Govt. of India during the Financial year 2017-2020. The PIO did not furnish any reply to the RTI application. The appellant then filed a First Appeal dated 22.05.2023. First Appellate Authority (FAA) vide order dated 09.07.2023 held that sought information is not covered under section 8 (1) (d) of the RTI Act and hence can be disclosed. The appellant then approached this commission through this instant Second Appeal.

FACTS EMERGING DURING THE HEARING:

After receipt of the Second Appeal notices were issued to the parties to appear on 24.11.2023.

None appeared on 24.11.2023. No request was also received from any of the parties for adjournment of the hearing. The commission adjourned the hearing to 25.01.2024.

Both the PIO and the appellant are absent. However, the PIO is represented by Shri. **Tai Dora** (APIO). Shri T.Dora has submitted that the information was furnished to the appellant on 28.06.2023 and the same was received by the appellant. The commission is in receipt of a letter dated **28.06.2023** from the appellant wherein he has stated that he has received complete information from the PIO.

DECISION:

Keeping in view facts of the case and the submission sent by the appellant, the commission is in opinion that complete information has been furnished by the PIO. The appellant has also showed satisfaction with the information provided. Hence, no further action is required in the matter. **The instant appeal is disposed.**


