**Information sought :**

The appellant file a RTI Application dated 18/10/2024 seeking Details regarding 1. C/o Storm drain work and culvert 5 nos. in around Dirang Circle. 2. C/o Approach road from BRTF road, traditional fate, Prayer hall and public toilet and CC step with railing for Cultural Mandalatop Dirang. 3. C/o Guest House, Cultural Centre, Tootpath,, Mini Stadium at Branch Sagor Khorng Nabdi Village.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 23/11/2024. No any hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Respondent : PIO-cum-EE(PWD), Dirang Division absent.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on 18/10/2024 filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Dirang Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in

Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23/11/2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17/02/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 192/2025, 193/2025 & 194/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) time i.e on 17/09/2025, 24/11/2025 and 16/03/2026. In this hearing of the appeal on **16<sup>th</sup> day of March, 2026**, both the parties PIO-cum-EE(PWD), Dirang Division, West Kameng District and the appellant Shri Mamu Sono found absent without any intimation to the Commission.

As per the order dated 24/11/2025 2<sup>nd</sup> hearing last chance was given to the appellant to collect the information from the office of the PIO and intimate to the Commission immediately. The Commission cautioned that if no intimation is made, the Commission will presume that the appellant has received all the information and satisfied.

On the last hearing the PIO also stated that the documents were ready to be furnished but the appellant never came to collect the information. Sufficient time has been given to the appellant to collect the documents, therefore, the Commission deems fit to dispose of this appeal case. This appeal case is disposed of and closed.
