Information sought :

The appellant file an RTI Application dated 18/10/2024 seeking Details regarding Construction of 52 Units of ACRS at whereas location of Govt. Primary Schools in West Kameng District, Bomdila..

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 23/11/2024. The First Appellate Authority has not conducted the hearing in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Mamu Sono present in person.

Respondent : PIO-cum-EE (PWD), Bomdila Division found absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono **18/10/2024** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on

23/11/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 12.02.2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 149/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2(two) times i.e on 03/09/2025 and 03/11/2025. In this hearing of the appeal on 3rd day of November, 2025, the appellant Shri Mamu Sono present in person but the PIO-cum-EE (PWD), Bomdila Division, West Kameng District is found absent without any intimation to then Commission.

However, the appellant has stated before the Commission that he has received all the information from the PIO through postal service and satisfied. He has requested to dispose of the appeal case.

Accordingly, the appeal case No. APIC-148/2025 is disposed of and closed in his absence.
