## **JUDGEMENT ORDER**

An appeal under section 19(3) of RTI Act, 2005 was received from Shri Adv. Takam Sakap, C/o 3D Hotel Chandranagar, ICR, Arunachal Pradesh, for non-furnishing of information, by The PIO-cum-Project Director, DRDA, Palin, Kra Daadi District, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 16.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"PD/DRDA Palin".

## The above subject has been mentioned in detail under 'Form - A'.

The 1<sup>st</sup> hearing was held on 02<sup>nd</sup> day of August' 2023. The appellant was present but the PIO was absent. Er. Byabang Sopang, APO, RE represented the case on-behalf of the PIO. Heard both the parties. The APIO furnished the documents sought by the appellant before the Court itself. The Court directed the appellant to go through the documents received and inform his satisfaction/dissatisfaction on or before next date of hearing fixed on 23<sup>rd</sup> August' 2023.

The 02<sup>nd</sup> hearing was held on 23<sup>rd</sup> day of August' 2023. Both the parties were present. Heard both the parties. The appellant informed the Court that he hasn't gone through documents furnished by the PIO, as directed to him by the Court in earlier hearing and he pleaded for some more time to go through it. Hence, the Court fixed next date of hearing for the case on 13<sup>th</sup> September' 2023.

The 03<sup>rd</sup> hearing was held on 13<sup>th</sup> September' 2023. Both the parties were present. Heard both the parties. The appellant informed the Court that the documents furnished by the PIO were incomplete. The Court directed the PIO to furnish complete documents to the appellant on or before next date of hearing fixed on 19<sup>th</sup> October' 2023.

The 04<sup>th</sup> hearing was held on 19<sup>th</sup> day of October' 2023. Both the parties were present. Heard both the parties. The PIO furnished the remaining documents before the Court itself to the appellant. The appellant received the same. The Court directed the appellant to go through the documents received and inform his redressals of satisfaction/dissatisfaction on or before next date of hearing fixed on 16<sup>th</sup> November' 2023.

The 05<sup>th</sup> hearing was held on 16<sup>th</sup> day of November' 2023. The appellant was absent but the PIO was present. The case was heard ex-parte. The Court seriously viewed the absence of the appellant without any intimation neither informed about his redressals of satisfaction/dissatisfaction to the Commission. Hence, the Court assumed that the appellant is no more interested and unwilling to pursue the case further. Therefore, the Court directed to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
