## JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from Shri Adv. Takam Sakap, C/o 3D Hotel Chandranagar, ICR, Arunachal Pradesh, for non-furnishing of information, by The PIO-cum-Executive Engineer, Public Health Engineering & Water Supply, Dirang Division, West Kameng District, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 16.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To Supply the information against allocation of fund under Jal Jeevan Mission(JJM) of entire PHE & WS Dirang Division for support activities and (WQM&S)".

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing was held on 28th day of June' 2023. The appellant and the APIO was present. Heard both the parties. The APIO informed the Court that the documents sought by the appellant will be furnished tomorrow as few paper works were remaining. The Court directed the appellant to receive the documents from the APIO and inform his redressals of satisfaction/dissatisfaction on or before the next date of hearing. Accordingly, the Court fixed next date of hearing for the case on 26th July' 2023.

The 02<sup>nd</sup> hearing was held on 26<sup>th</sup> day of July' 2023. Both the parties were present. Heard both the parties. The appellant expressed his satisfaction for all the documents received and pleaded before the Court to dispose of the case. As such, the Court directed to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
