JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Ashok Sangbia on **09/07/2025** filed an RTI application in form 'A' before the PIO-cum-Executive Engineer, PWD, Dirang Division, West Kameng District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in his Form 'A' application. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **25/08/2025**. Appellant again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on **09/10/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **756/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **05.03.2026** wherein both the parties present through online mode during the hearing before the Commission.

Details of Information sought from the PIO;

- i) Category of work charged (W/C) serving under your division and sub-division.
- ii) Appointment letter of all the W/C staff serving under your division and sub-division.
- iii) Place of posting of all the W/C staff serving under your division and sub-division.
- iv) Approval from competent Authority CE or SE, advertised details, Interview or viva voice detail, videography during written exam conducted, along with board formed then details of all the W/C staff recruited under your division and sub-division.
- v) Present strength of W/C staff under your division and sub-division.
- vi) New strength of or against retirement or vacate of W/C staff under your division and sub-division.
- vii) Total sanction strength of W/C staff under your division and sub-division.
- viii) Recruitments rule (RR) of W/C staff serving under your division and sub-division.

Period for which information asked for:-2016 to till date.

The first and final hearing held today on 05.03.2026 related to APIC-No. 755/A/2025, the Appellant and the PIO are present through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the PIO has provided him the information(s) as per his Form-A, except the information(s) sought, listed under S/Nos. b & h.

Heard the PIO;

The PIO stated that all the information(s) which are available with him have been provided to the Appellant, and regarding the information sought under Serial Nos. b & h of the Form-A it cannot be provided because these information(s) are not available with his office, as these information(s) are available only with the competent authority which is the Superintendent Engineer (SE), PWD, Rupa Circle, and the appellant may apply it from that particular office.

After hearing both the parties the Commission hereby decides;

- i) The PIO has provided all the information(s) to the Appellant which are available in the office of the PIO.
- ii) The Appellant also admitted that he has received all the information(s) from the office of the PIO.

Under the above stated facts and observations the Commission hereby dispose of this appeal.

Order:

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed once for all.
