**Information sought :**

The appellant file a RTI Application dated 20/11/2024 seeking Details regarding C/o Cultural Centre at Chillepan (Phase-II) under Rupa Circle.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 20/12/2024. First Appellate Authority has been conducted hearing in his jurisdiction on 20/12/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Mamu Sono absent.

Respondent : PIO-cum-EE(PWD), Kalaktang Division present in person.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **20/11/2024** filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Kalaktang Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in

Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 26/12/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 27/02/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 229/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 24/09/2025 and 08/12/2025. In this hearing of the appeal on **8<sup>th</sup> day of December, 2025**, PIO-cum-EE(PWD), Kalaktang Division, West Kameng District present in person but the appellant Shri Mamu Sono found absent without any intimation to the Commission.

Perusing the case record, the appellant was given sufficient time to collect information from PIO by the FAA. But appellant never went to collect the sought information.

Today the appellant is consecutively absent second time without any intimation to the Commission. The PIO stated that he was always ready to furnish all the information as sought but never came to collect the information.

Therefore, the Commission presumes that the appellant is no more interest to pursue this appeal case. The appeal case No. APIC 229/A/2025 is disposed of and closed.
