JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Yogesh Yadav on 18.03.2023 filed an RTI application under Form-'A' before the PIO-O/o the Himalayan University, Jollang, Itanagar P/Pare District, Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 18.04.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 26.07.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 930/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) times i.e on 18.12.2023 & 22.01.2024. In this hearing of the appeal on 22nd day of January, 2024. The appellant shri Yogesh Yadav & the PIO present during the hearing.

However, the appellant has submitted a letter during the hearing to the Commission that he has received all the information as sought in the Form-'A' application and requested for disposal/closer of his appeal on the ground of satisfactorily receipt of all the information sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed for once for all.
