Information sought :

The appellant filed an RTI Application dated 22/08/2025 seeking Details regarding relevant information against the works carried out under the funding Head of Accounts '4801'- Maintenance of ASSETS for the year 2022-23- Rs. 43.12 lakhs, 2023-24- Rs. 100.00 lakhs & 2024-25- Rs. 100.00 lakhs.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 02/10/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram **22/08/2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer Power), Longding Electrical Division, Longding District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **02/10/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **03/11/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 822/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 27/05/2026. In this hearing of the appeal on 27th day of May, 2026, Appellant Shri Riya Taram present in person but PIO-cum-Executive Engineer Power), Longding Electrical Division, Longding District, found absent, however, the appellant has stated that he has received all the information from the PIO and index of documents is provided to the Commission

Therefore, the appeal case No. APIC-822/A/2025 is disposed of and closed.


