**JUDGEMENT/ORDER**

This is an appeal filed under sub-section (1) of Section 18 of the RTI Act, 2005. Brief fact of the case is that the Complainant Shri Tania June on 17.01.2023 filed an RTI application under Form-'A' before the PIO-Cum-The Director of Printing/press, Papu/Nallah, Nahralagun, P/pare District, Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority, Complainant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 01.02.2023 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as APICs No. 94/20223 & 96/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 6 (Six) times i.e on 20.03.2023,01.05.2023, 22.05.2023, 19.06.2023,07.08.2023 & 25.09.2023. In this hearing of the appeal on 25<sup>th</sup> day of September,2023. The Complainant present during the hearing but the PIO is found absent.

However, the Complainant during the last hearing dated on 25.09.2023 submitted a letter to the Commission that he is fully satisfied with the action taken by the Commission against the PIO during the hearing and requested for disposal/closer of his Complaints.

In view of the above facts and circumstances, I find this Complaints fit to be disposed of and closed. And, accordingly, this Complaint stands disposed of and closed for once for all.
