**Information sought :**

The appellant file a RTI Application dated 24/06/2025 seeking Details regarding Appointment order, place of posting, approval from competent authority., advertisement details, present strength, new strength etc. of W/C staff under the Sub-Division.

As per the case record, PIO did not provide the sought information.

Being dissatisfied, the appellant filed First Appeal dated 29/07/2025. First Appellate Authority had conducted hearing in his jurisdiction on 22/08/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ashok Sangbia on **24.06.2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Electrical), Rupa Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **29.07.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **05.09.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 675/A/2025**, and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 11/02/2026. In this hearing of the appeal on 11<sup>th</sup> day of February, 2026, both the parties the appellant Shri Ashok Sangbia and the PIO-cum-EE (Electrical), Rupa Division present in person.

On the hearing dated 11/02/2026, the PIO has assured to provide the remaining document to appellant very soon as per the Form 'A' application.

The appellant was directed to collect the remaining information from the PIO and intimate to the Commission within one month after receiving the information. If no intimation is made, the Commission will presume that the information has been received and is satisfied and accordingly, the case will be decided.

As per the order dated 11/02/2025, the appellant has intimated through a telephonic call and also submitted a letter of intimation regarding the information he sought for. The appellant is satisfied by the information provided.

Therefore, the Commission deems fit to dispose of and close this appeal case. Accordingly, this appeal case is disposed of and closed.
