Information sought :

The appellant filed an RTI Application dated 27/02/2025 seeking Details regarding Implementation of items under CA, WLMP & NPA component of the State CAMPA AOP (Vol-I during 2024-25) in respect of DFO, Aalo FD under Department of Environment Forest & Climate Change.

As per the case record, PIO has furnished all the sought information.

Being dissatisfied, the appellant filed First Appeal dated 21/04/2025. First Appellate Authority had conducted hearing in his jurisdiction and disposed of the appeal case. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Teli Naga absent.
Respondent : PIO-cum-DFO, Aalo Forest Division absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Teli Naga on **27/02/2025** filed an RTI application under Form-'A' before the PIO-cum-DFO, Aalo Forest Division, West Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21/04/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **06/06/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 423/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 09/02/2026 and 18/05/2026 In this hearing of the appeal on 18th day of May, 2026, both the parties, PIO-cum-DFO, Aalo Forest Division and the appellant Shri Teli Naga found absent without any intimation to the Commission.

The appellant was cautioned in the last hearing that if he is found absent in the next date of hearing the appeal case will be heard in his absence. Today the appellant is absent without any intimation to the Commission, therefore, the Commission presumes that the appellant has received all the information and is satisfied.

Therefore, this appeal case is disposed of and closed.
