This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Nabam Bida, Village Rushi Sangdupota Circle, PO/PS Balijan, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PHE & WS), Govt. of A.P., Itanagar Division, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 16/10/2025 regarding P/W/S to Rushi village under JJM scheme.
- 2). The 1<sup>st</sup> hearing was held on 5<sup>th</sup> May' 2026. The PIO-cum-EE (PHE & WS), Govt. of A.P., Itanagar Division, Papum Pare District, Arunachal Pradesh, was represented by Er. Harang Sonam, APIO-cum-AE (PHED & WS), Itanagar Division. The Appellant was represented by Shri Chera Taji.
- 3). The APIO produced a copy of Memo No. EE/phed/ITA/PB-85/2026-27/05-07 dated 24/04/2026 before the Commission and submitted that there was no such work executed under the JJM Scheme, and therefore, the information sought by the Appellant did not exist.
- 4). The representative of the Appellant obtained a copy of the above mentioned letter.
- 5). In view of information furnished by the PIO, the Commission decided to dispose of the case.
- 6). Therefore, the case is hereby disposed of.
