JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Donik Roru & Shri Khyoda Tacha, Jully-II Colony, PO/PS-Itanagar, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-EE, Capital Electrical Division, Dept. of Power, Itanagar, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 12.06.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"United Fund for the period 2022 to 2023 (till date)."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 31st Day of January' 2024. Both the parties were present. After hearing both the parties, the court disposed of the case as the appellant had been provided with the information sought by him from the representative of the PIO. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
