**Information sought :**

The appellant file a RTI Application dated 29/10/2024 seeking Details regarding C/o Construction of Multipurpose Centre at Nafra, West Kameng during the financial year 2023-245.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 20/01/2025. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Tamchi Gunte absent.

Respondent : PIO-cum-EE(PWD), Bomdila Division attended through VC.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gunte on **29/10/2024** filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **20/01/2025**, Appellant, again having not received the

required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17/03/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 256/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 24/09/2025 and 08/12/2025. In this hearing of the appeal on **8<sup>th</sup> day of December, 2025**, PIO-cum-EE(PWD), Bomdila Division, West Kameng District attended the hearing through VC but the appellant Shri Tamchi Gungte found absent without any intimation to the Commission.

As per the case record, the First Appellate Authority had already given sufficient time to collect the information which was ready to be furnished. PIO stated today that the appellant had been intimated many times to collect the information as sought by him. But he never came to collect the information from the office of the PIO.

The Commission had given last chance on the hearing dated 24/09/2025 for collecting the information from the office of the PIO and intimate to the Commission whether he has received all the information or not. But today appellant is found absent without any intimation to the Commission.

The Commission presumes that the appellant has collected the information from the PIO and satisfied, therefore, the appeal case No. APIC-256/A/2025 is disposed of and closed.
