ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chow Lajamang Mannow, Village Piyong Khampti, P/O- Piyong, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PHE & WSD), Bordumsa Division, Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/03/2025 regarding Augmentation of Water supply at Miao Township (3.57MLD) in Arunachal Pradesh.
- 2). The 2nd hearing was held on 21st April' 2026. Er. Kipa Nyama, PIO-cum-EE (PHE & WSD), Bordumsa Division, Changlang District, Arunachal Pradesh had appeared before the Commission through online mode of hearing. The Appellant Chow Lajamang Mannow had appeared before the Commission in person.
- 3). The Appellant informed the Commission that the PIO had not furnished information for Sl.no. m & o.
- 4). The PIO submitted that the information sought at 'Sl.no. m & o' are voluminous and cannot be furnished.
- 5). The Commission had directed the PIO to let the Appellant have inspection / verification of the information sought at 'Sl.no. m & o' of the Form-A application dated 17th December'2024 and if required let the Appellant have the clips of any pages. In case, information were not available, the PIO was directed to give justifiable reasons in writing through AFFIDVIT to the Appellant under intimation to the Commission within fifteen days from the date of issue of the order dated 21st April'2026.

6). The Appellant was asked to intimate his satisfaction or dissatisfaction to the Commission after receipt of information from the PIO within ten days from the date of receipt of information.

7). Caution was given to the Appellant that in case the Appellant failed to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.

8). Since, the Appellant has not intimated as directed, the Commission decided to dispose of the case.

9). **Therefore, the case is hereby disposed of.**
