JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June, C/o Post Office Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO –cum-DFO Khonsa, Khonsa Forest Division, Tirap District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 19.11.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details regarding Expenditure & Implementation under CAMPA Schemes/ VRF/ ARF of entire Tirap District for the year 2015 to 2022(till date)."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 28th of June'2023. Both the parties were present. After hearing both the parties, the PIO had furnished the information as sought by the appellant during the hearing of this case. The appellant received the same and was directed by the Court to go through the same and express his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on the 26th day of July'2023.

The 2nd hearing of this case was held on the 26th day of July'2023. The appellant was present. The representative of the PIO, Shri Wangrao Hakhun (RO, Lazu) was also present. After hearing both the parties, the representative of the PIO had been directed by the Court to furnish the left-out information on or before the next date of hearing of this case fixed on 17th day of August'2023.

The 3rd hearing of this case was held on the 17th day of August'2023. The appellant was absent but the representative of the PIO, Shri Wangrao Hakhun (RO, Lazu) was present. The left-out information was provided by the representative of the PIO during the Court proceedings itself and handed over to the Court. The Commissioner's office would contact the appellant to collect the documents. The appellant should go through the same and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on the 13th day of Sept'2023.

The 4th hearing of this case was held on the 13th day of Sept'2023. Both the parties were present. After hearing both the parties, the appellant informed the Court that he had received all the information as sought by him from the PIO and pleaded before the Court for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
