**Information sought :**

The appellant file an RTI Application dated 04/10/2024 seeking Details regarding Implementation of the items under "CA, NPA & CAT plan" component of the State CAMPA APO Vol-I during the financial year 2022-23.

As per the case record, PIO had furnished some of the documents which are available in the office.

Being dissatisfied, the appellant filed First Appeal dated 09/10/2024. The First Appellate Authority has been conducted hearing in his jurisdiction on 21/11/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte 04/10/2024 filed an RTI application under Form-'A' before the PIO-Cum-DFO, Bomdila Forest Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **09/10/2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21/11/2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 13/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) times i.e on **09/09/2025** and **10/11/2025**. In this hearing of the appeal on **10<sup>th</sup> day of November, 2025**, the PIO-cum-DFO, Bomdila Forest Division, West Kameng District is represented by Shri Petor Tali, RFO and the Appellant Shri Tamchi Gungte present in person.

On the 2<sup>nd</sup> hearing dated 10/11/2025 the appellant has brought remaining information which was not furnished and handed over to the appellant. The appellant was directed to go through the documents and intimate to the Commission within one week.

As per the order dated 10/11/2025, Appellant Shri Tamchi Gungte has submitted an application addressed to the Commission stating that after going through all the information provided by the PIO, he is satisfied and requesting to dispose of the appeal case No. APIC-13/2025.

Request accepted and the appeal case No. APIC-13/2025 is disposed of and closed.
