JUDGEMENT ORDER

-V/S-

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Tania June & Shri Nikam Dabu, C/o Post Office Naharlagun, Arunachal Pradesh, for non-furnishing of information, by the PIO –cum-DFDO, Dept. of Fishery Daporijo, Upper Subansiri District, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 22.09.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details Regarding Appointment of UDC/LDC/Peon/Driver/ Group B, C, & D/All MTS Posts/Contingency of entire Upper Subansiri District for the period from 2018 to 2022 (Till Date)."

The above subject has been mentioned in detail under 'Form -A'.

The 1st hearing for the case was held on the 08th day of February'2023. The PIO was present. The appellant was also present. After hearing both the parties, the PIO furnished the documents as sought by the appellants during the Court proceedings itself. The appellant received the same and was directed by the Court/Commission to go through the same and express their satisfaction/dissatisfaction on or before the next date of hearing of this case. The next hearing of this case was fixed on the 22nd day of February'2023.

The 2nd hearing for the case was held on the 22nd day of February'2023. The appellant was present. The representative of the PIO, Shri Chiging Challo (F.D) was also present. After hearing both the parties, appellant had expressed his satisfaction for all the information received from the PIO and pleaded before the Court for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
