Information sought:

The appellant filed an RTI application dated 12.05.2025 seeking following information regarding as according to the sanctioned list of approved projects under vibrant villages programme (VVP) during 2023-2025 (First Tranche). Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the appellant, observes that FAA – Project Director (PD/ DD) DRDA Koloriang, Kurung Kumey District has not heard the first appeal filed to him in spite of commission's order dated 22.12.2025. In today's hearing both FAA and PIO is found absent.

The information sought by the appellant is regarding project schemes under Vibrant Village Program (VVP) during 2023 – 2025. If the tender process of the schemes is completed, the PIO is directed to furnish the information sought to applicant within two weeks from the date of issue of this order. The appellant shall serve a copy of this order to the office of the PIO – Block Development Officer, Parsi Parlo CD Block and obtain acknowledgement receipt. A copy of acknowledgement receipt so obtained shall be submitted to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant, this appeal case shall stand closed.


