JUDGEMENT ORDER

-V/S-

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June**, **C/o Post Office**, **E-sector Naharlagun**, **Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum-BDO**, **Gangte CD Block**, **Kra Daadi District**, **Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 30.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details regarding Expenditure and Implementation of work under MGNREGA/ Supply Work/ Pending Work/ New Work/ Sanction Order/ Complete Work from 2014 to till date. "

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 22nd day of November'2023. The representative of the PIO, Shri Biki Tadam EO(RE) was present. The appellant was also present. After hearing both the parties, the representative of the PIO had informed the Court that he hadn't received the Form-A of the appellant. However, he had prepared and brought the information relating to this case which was similar to APIC NO. 497/2023 filed by an appellant Shri Dongru Tania and handed over to the appellant during the hearing of this case. The appellant received the same and was directed by the Court to go through the same and inform his satisfaction/dissatisfaction on or before the nest date of hearing of this case. The next date of hearing of this case is fixed on the 20th day of Dec'2023.

The 2nd hearing of this case was held on the 20th day of December'2023. The appellant was present. The PIO was absent. During the hearing of this case the appellant informed the Court that, the documents as sought by him were provided by the representative of the PIO during the last court proceedings and after going through the same he is fully satisfied with the information provided by the PIO and further pleaded before the Court for disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
