## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/PS Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-EE(PWD), O/o the Executive Engineer (PWD), Dirang West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 31/05/2025 regarding work executed during the year2024-2026 under PWD Dirang Division.
- 2). The 1<sup>st</sup> hearing was held on 11<sup>th</sup> November' 2025 as scheduled. Shri Khoda Tabin, APIO, represented the PIO-cum-EE(PWD), Govt. of A.P. Dirang Division, West Kameng District, Arunachal Pradesh through video conference. Shri Tamchi Gungte, the Appellant was absent.
- 3). The representative of the PIO stated that all the information as sought by the Appellant has submitted to the office of the First Appellate Authority-cum-SE (PWD), Rupa. The First Appellate Authority had served letter on 30<sup>th</sup> July'2025, to the Appellant to collect the information from the SE (PWD), Office Rupa in the office hours and asked to reply within 15 days from the date of issue of the letter and confirm his satisfaction or dissatisfaction. However, the Appellant did not comply with the order.
- 4). The Appellant was absent for the hearing and it is assumed that he is no more interested with the information.
- 5). Based on the input provided by the PIO-cum-EE (PWD) Dirang Division, West Kameng District, Arunachal Pradesh, the Commission finds it fit to dispose of the case.

Therefore, the case is hereby disposed of.
