ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa PO/PS Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Pake Kessang Division, Pakke Kessang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 29/05/2025 regarding Work Charge (W/C) serving under the Pakke Kessang Division & Sub-Divisions.

2). The 2nd hearing was held on 3rd March' 2026. Shri Mibom Tayeng, PIO-cum-EE (PWD), Pake Kessang Division, Pakke Kessang District, Arunachal Pradesh was represented by Shri Niya Gumro, Divisional Accountant, Pake Kessang Division. The Appellant Shri Ashok Sangbia had appeared before the court through Video Conferencing.

3). During the 2nd hearing, the Commission had provided the Appellant contact number of the APIO with caution to contact only during the office hours, that too only to collect the information. The APIO was directed to furnish information to the Appellant within two weeks from the date of issue of the order dated 3rd March'2026, and was also cautioned to attend the call from the Appellant.

4). The Commission had directed the Appellant to give the detailed list of the incomplete information to the PIO with intimation to the Commission, in case information furnished was incomplete, or in case complete information was furnished, intimate his satisfaction or dissatisfaction to the Commission within fifteen days from the date of issue of the order, failing which the case shall be disposed of.

5). Till date the Appellant had not intimated, the Commission in view of the order dated 3rd March'2026 decided to dispose of the case.

6). Therefore, the case is hereby disposed of.
