Information sought :

The appellant file an RTI Application dated 18/10/2024 seeking Details regarding construction of District sale Emporium-cum-Conference Hall at Bomdila.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 28/11/2024. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Mamu Sono absent.
Respondent : PIO-cum-EE (WRD), Bomdila Division present.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **18.10.2024** filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (WRD), Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various

information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **28.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **22.01.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 102/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two time i.e on 08/09/2025 and 10/11/2025. In this hearing of the appeal on 10th day of November, 2025, the PIO-cum-EE (WRD), Bomdila Division present in person but the appellants Shri Mamu Sono found absent without any intimation to the Commission.

On the last hearing the appellant was absent without any intimation to the Commission and the PIO had brought all the information as sought by the appellant. Today again the appellant is found absent without any intimation to the Commission. On the last hearing dated 8/9/2025 the appellant was already warned that if he is absent, the case will be heard in his absence.

Today the appellant is absent without any intimation to the Commission, but PIO has brought all the documents sought by the appellant but could not be handed over to the appellant due to his absence.

The Commission presumes that the appellant is no more interested to pursue this appeal case. Therefore, the Commission deem fit to dispose of this appeal case. This appeal case No. 101/2025 is disposed of and closed.
