



## ARUNACHAL PRADESH INFORMATION COMMISSION ITANAGAR.

**An Appeal Case U/S 19(3) of RTI Act, 2005**

### ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Ngwazosa Yobin for non-furnishing of below mentioned information by the PIO, o/o the Block Development Officer-cum-CO Vijoynagar CD Block, Changlang District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 19.05.2025:

**A) Particular of information:** MGNREGA Scheme, Vijoynagar CD Block especial for 2021.

**B) Details of information required:**

1. Furnish the total fund allocation under MGNREGA in 2021;
2. The details beneficiary list of MGNREGA for 2021;
3. The details list of DBTL, bank transaction of the beneficiaries;
4. Location of the works with photographs before and after;
5. Geo-tagged location where works have been executed;
6. Utility certificate (UC) by audit report of the Financial Accounting Officer (FAO)
7. Work completion report.

### Brief facts and decision:

Records emerging from the appeal disclose that the Appellant, Shri Ngwazosa Yobin had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the, Deputy Director, RD, Changlang, Changlang District as the First Appellate Authority(FAA) under Section 19(1) of the RTI Act vide his appeal Memo dated 07.07.2025.

There is, however, no record of the FAA's conducting the hearing of the appeal but vide his letter dt. 18.07.2025, directed the BDO, Vijoynagar CD Block to furnish the information to the appellant.

The appellant, apparently, having failed to obtain the information from the PIO despite direction from the FAA, filed his 2<sup>nd</sup> appeal before this Commission under Section 19(3) of the RTI Act vide Memo of appeal dt. 12.09.2025.

Accordingly, this appeal is listed for hearing on 28.01.2026 and summon was issued on 18.12.2025. This Commission is, however, in receipt of letter dt.22.12.2025 from Shri Ngwazosa Yobin, the appellant intimating that the PIO has furnished the requested information/documents and that the appeal may be disposed of accordingly.

In the premises as above, this Commission concludes that this appeal does not require any consideration by this Commission and resultantly, it stands closed and the hearing fixed on 28.01.2026 stands cancelled.
