The appellant filed an RTI application dated 21.01.2025 seeking following information regarding MGNREGA from 2020 to till date.

- Certified copy of Notice inviting Tender (NIT) of Material procurement under your CD Block from 2020 to till date.
- Certified copy of Newspaper cuttings of (NIT) published in State/Local Newspaper from 2020 to till date.
- Certified copy of all the Board Members of tender processing from 2020 to till date.
- Certified copy of the Firm/Vendor/Supplier who won the tender and did the work from 2020 to till date.
- Certified copy of payment done to Firm/Vendor/Supplier i.e cheque leaf's /DD/PFMS/Cash/RTGS in details.
- Certified copy of material procurement/bill year wise in details from 2020 to till date.
- Certified copy of all the firms/vendor who participated and submitted the bids
 - Technical Bids

- (ii) Financial Bids
- h. Certified copy of firms qualified in technical bid and participate in technical and financial bid along with comparative statement.
 - i. Certified copy of GST Reg. No., Income Tax Clearance Certificate. Latest Audit Report of last 3 (three) years duly certified/audited by Chartered Accountant of the firm, Bank Solvency Certificate, Firm Registration Certificate of the Firm/Vendor/Supplier who did the work year wise.
 - j. Certified copy of name of all BDO, EO who executed/implemented the said work/schemes from 2020 to till date.
 - k. Certified copy of Geo-Tag, Geo-Coordinate. Photographs. Videography of the work Panchayat wise from 2020 to till date.
 - l. Certified copy of cashbook statement with page numbers or give hand receipt with payee name of the said work.
 - m. Certified copy of bill of the said work.
 - n. Certified copy of affidavit of having not more than 2(two) works in hand under the State Govt. by the Firm.
- Period from which information is asked for: - 2020 to till date

Relevant facts emerged during hearing:

Previous Hearing:

First : 06.03.2026

Order of the 1st hearing- *"The Commission has directed the PIO to comply with the FAA's order dated 29.04.2025. The audio was not clear during hearing through VC due to erratic network. Both the PIO and appellant were directed to attend the hearing in person on 10.4.2026"*.

The following were present.

Appellant : Present. He states that he has received some information document from the PIO but the information does not conform to the item of information sought. The information was furnished without index of items and forwarding letter. Information only at serial number e), f) and m) has already been received.

Respondent PIO : Absent without any intimation.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the appellant, observes that the PIO was absent in today's hearing without any intimation irrespective of this commission's order to attend in person.

The PIO is directed to furnish information / reply to RTI query at serial numbers 5 (a) b) (c) (d) (g) (h) (i) (j) (k) (l) n) and 6) in RTI application in form-A within two weeks from the date of issue of this order. The PIO is directed to comply this order within the prescribed timeline under intimation to this commission. She is warned against negligence of this commission's order. The appellant shall file a written submission of the satisfactory information received or non-received of information based on this order to this commission within three weeks from the date of issue of this order.


Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant. In case no compliance report is received at commission from the appellant within stipulated time, this appeal case shall stand closed.
