JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Byabang Bhute on **25/10/2024** filed an RTI application under Form-'A' before the PIO-Cum- CE, (UD & Housing) Mob-II Itanagar Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12/12/2024**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **6/11/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-218/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2nd hearing on **14/10/2025**.

Details of information sought by the Appellant.

1. Parking lot near Malo Tarin GHSS, Itanagar.
2. Name of the Project and total cost of the Project.
3. Land allotment copy.
4. Work order copy and name of the Firm owner.
5. NOC copy obtained from the concerned department.
6. Tender date and year.

The 2nd hearing held on **14th October 2025**, related to the APIC No-218/2025 (Appeal). The Appellant Byabang Bhute, represented by Byabang Nehru is present during the hearing and the PIO -cum EE (UD & Housing) present during the hearing.

Heard both the parties.

The representative of the Appellant Shri Byabang Bhute stated that he has not got the information(s) pertaining to Sl No.2 & Sl.No-4 of his Form 'A' application till now, and the rest information(s) have been provided.

The PIO stated that the Appellant filed First Appeal before the Court of First Appellate Authority (FAA) which is the CE (UD & Housing) to which the First Appellate Authority (FAA) CE (UD & Housing) held the hearing of both parties on 3rd January 2025 and pronounced the judgment that the information with the PIO have been provided to the Appellant and therefore, the Appeal was disposed of.

The Commission hereby observes;

- i) An acknowledgement receipt from the Appellant on 3/12/ 2024, is exhibited by the PIO, wherein the full details are given with statement from the Appellant that he has verified and received all the documents sought in his Form 'A' application. Further the Appellant has declared that he is satisfied with the information(s) furnished to him by the PIO.
- ii) On satisfying with the acknowledgement receipt signed by the Appellant, the Court upholds the judgment of the First Appellate Authority (FAA), to dispose of the First Appeal and following the procedural laws and going through the facts of this instant appeal the Commission hereby while upholding the decision of the First Appellate Authority (FAA) dispose of this appeal.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
