### **JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Riya Taram & Shri Takam Sakap, C/O Hotel River View, Barapani Naharlagun, Arunachal Pradesh, for non-furnishing of information, by the PIO-cum-EE, PWD Jairampur Division, Changlang District, Govt. of Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 03.03.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish all the relevant documents of Allocation of Fund Sanction under SIDF/ RE/Additional RE/BE /ADA/MLALAD/ MPLAD/ SPA/ SJETA/ CCI/ SADA/ CMCDRP/ SIDF & Additional which are implemented in all the CD Blocks under PWD Jairampur Division for the year 2015 to till date."

The above subject has been mentioned in detail under 'Form -A'.

The 1<sup>st</sup> hearing for the case was held on the 22<sup>nd</sup> day of Nov'2023. The PIO was present. Shri Tania June represented on behalf of the appellant. After hearing both the parties, the PIO had been directed by the Court to provide only the Sanction Order of the information as sought by appellant on or before the next date of hearing of this case fixed on the 20<sup>th</sup> day of Dec'2023.

The 2<sup>nd</sup> hearing of this case was held on the 20<sup>th</sup> day of Dec'2023. Both the parties were present. After hearing both the parties, the Court directed the PIO to furnish the documents to the appellant pertaining to SIDF 2018-2019 only on or before the next date of hearing of this case fixed on the 17<sup>th</sup> day of Jan'2023.

The 3<sup>rd</sup> hearing of this case was held on the 17<sup>th</sup> day of Jan'2023. The appellant was absent but the PIO was present. During the hearing of this case, the PIO informed the Court that he had furnished the left-out information to the appellant by post (postal ID enclosed). On this the court disposed the case with a liberty to the appellant to file a fresh case if any information is found missing/incomplete from the PIO. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
