ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near, KV2 School, Chimpu, Itanagar, Arunachal Pradesh for non-furnishing of information by the SPIOcum-EE (RWD), Govt. of A.P. Deptt. Rural Wokrs Department, Longding Division, Longding District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/04/2023 regarding construction of 30 bedded Community Health Care (CHC) at Kanubari in Kanubari block in Longding Dist. A.P.

The 1st hearing is held today on 17th October, 2023 as scheduled. The SPIO-cum-EE (RWD), Govt. of A.P. Deptt. of Rural Wokrs Department, Longding Division, Longding District, Arunachal Pradesh is represented by Shri Michi Yube, APIO-cum-AE(RWD). The Appellant Shri Tamchi Gungte is present.

The APIO submitted that the project is a new one and is at the initial stage and not yet started. So, the all the available information are brought to furnish to the Appellant. The APIO handed over a bunch of documents to the Appellant. The Appellant received the same and appealed the Commission to give time for verification of the information.

The Commission giving reasonable opportunity to verify the information directs the Appellant to intimate the Commission of his satisfaction or not satisfaction within two weeks' time from the date of issue of this order and also directs the Appellant to contact the SPIO and get all the information before the next date of hearing. So, that the case may be disposed of in the next date of hearing.

Both the parties are directed to be present before the Commission's court on the next date of hearing. If the SPIO is found absent the Commission may be compelled to invoke penal provision under section 20(1) of the RTI Act 2005 and in case the Appellant remains absent the case shall be disposed of without any further notice presuming that the SPIO has furnished information and the appellant is satisfied with the same.

The next date of hearing is fixed on 12th December, 2023 (Tuesday) at 1030 hrs.

Therefore, the SPIO-cum-EE (RWD), Govt. of A.P. Deptt. Rural Wokrs Department, Longding Division, Longding District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
