## ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Riya Taram, C/o Hotel River View, Naharlagun, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the SPIO-cum- EE(RWD), Anini Division, Dibang valley District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/05/2023 regarding **the Fund phase-1 during 2019-2020/2020-21/2021-22/2022-2023.** 

The 2<sup>nd</sup> hearing is held today on 16<sup>th</sup> January' 2024 (Tuesday) at 1030 hrs, the Appellant Shri Riya Taram is absent. Er. Kardo Nyigyor, PIO-Cum- Executive Engineer (WRD) is present and he has submitted that the information sought for various schemes like SIDF, MLAD Fund untied dated fund etc. from 2019 to 2023 which are not available with the department. However, the PIO has agreed to furnish information of financial year of 2021-2022 & 2022- 2023 of SIDF scheme. The PIO is directed to furnish the information of SIDF of Financial Year 2021-2022 & 2022- 2023 directly to the Appellant and with an intimation of the same to the Commission.

The Appellant is directed to collect the information from the office of the PIO Anini. With this direction the case is disposed of as the Appellant is absent for 2 consecutive hearings as during the 1<sup>st</sup> hearing it was clearly directed both the parties to appear in the court failing which the case will be disposed of.

Hence, the case is disposed of and closed.
