ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Nabam Nakap, C/o Nabam Yapu, Rono vill. PO Doimukh, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE (E), Planning Govt. of A.P. o/o Superintending Executive (E), A.P. Electrical Circle No. I-cum-Coord, Department of Power, Naharlagun, Papum Pare, District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/04/2023 regarding **List of grade A,B,C, and WC working under Papum Pare Division.**

The 1st hearing is held today on 17th October, 2023 as scheduled. Ms. T.Lollen, the SPIO-cum-EE (E), Planning Govt. of A.P. o/o Superintending Executive (E), A.P. Electrical Circle No. I-cum-Coord, Department of Power, Naharlagun, Papum Pare, District, Arunachal Pradesh is present. The Appellant Shri Nabam Nakap is absent. The SPIO has submitted that she has responded to the request of the information seeker on 3rd May, 2023. The information sought for are not under the control of the Superintendent Engineer (Coord), and those information can be sought from the divisions of the Power Department. The Appellant has been informed of the name of the Divisions from where information can be sought. She also has submitted that all the available information under her control of Superintendent Engineer (Coord) has been furnished to the Appellant. Further, the SPIO informed that the Appellant has made Superintendent Engineer as FAA but as per the notice of the Government actual FAA is Chief Engineer.

On perusal of the documents it is found that the Appellant has not complied with the response of the SPIO in making fresh application to the concern SPIOs of the Divisions. It is also found that the First Appellate Authority to whom the Appeal was to file is the Chief Engineer and not the Superintendent Engineer. The Commission, in view of the facts and circumstances decides to dispose of the case with a liberty to the Appellant to file a fresh application to the concern SPIO in Form-A.

Therefore, the case is hereby disposed of.
