ORDER

This is a complaint under Section 18(1) of RTI Act, 2005 received from Shri Tame Tallang and Shri Tadar Rokpo for non furnishing of below mentioned information by the PIO o/o the President/ Secretary General PAAHQ Nirjuli Arunachal Pradesh as sought for by them under section 18(1) (Form-A) of RTI Act, 2005 vide their application dated 09.09.2024.

A) Particular of information: Seeking information to PAA Election 2019-2025 and 2025-2029.

B) Details of information required:

1. Nomination form of all elected/ selected executive member of PAA 2025-29 with all required documents submitted by the candidates elected/ selected.
2. President approval copies of Returning Officer for PAA election 202-29.
3. President approval copies of Special Olympic Association along with district and state federation for affiliations.
4. Appointment order copies of executive member of PAA 2019-2025

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Tame Tallang and Shri Tadar Rakpo of Gandhi Market, Itanagar had requested the PIO for the aforementioned information / documents but failed to obtain the documents from the Secretary General-cum-PIO. It is also seen that the Secretary General-cum-PIO vide his letter dtd. 11.09.2025, requested the appellants to collect the documents after submitting the prescribed challan/fee of Rs. 1,980/- (Rupees one thousand nine hundred and eighty) only), Calculated @Rs. 10/- per page as printing charges of 198 pages. The letter of the PIO is reproduced below :

"Sir,

With reference to your RTI application letter received on 10th September 2025, the following Information is hereby furnished in respect of the Paralympic Association of Arunachal (PAA) Election 2025-2029:

Information Furnished:

1. *Nomination Forms of all elected/selected Executive Members for the term 2025-2029, along with relevant documents submitted by the candidates-furnished at pages 1 to 89.*
2. *Copies of President's approval of the Returning Officer (RO) for PAA Election 2025-2029 furnished at pages 90 to 91.*

3. Approval copies from the President, Special Olympics Bharat Arunachal, and other affiliated units under the PAA furnished at pages 92 to 170.
4. Appointment Orders of Executive Members of PAA for the term 2019-2025 furnished at pages 171 to 198.

You are therefore requested to kindly come and collect the above-mentioned documents after submitting the prescribed Challan/fee of 1,980/- (Rupees One Thousand Nine Hundred Eighty only), calculated @ 10 per page as printing charges (198 pages), payable to the following account:

Aggrieved with the letter of the PIO for over-charging of Rs. 10 per page the appellants complained against the PIO and informed that as per RTI Rule Rs. 2 per page should have been charged.

The appellants having failed yet again and due to over-charges for the documents preferred their second appeal Under Section 18 (1) dt. 13.10.2025.

This appeal was, accordingly, listed today on 06.03.2026 but none appeared.

This Commission, therefore, concludes that the parties, more particularly, the appellant is no longer interested in the information or he has received the information from the PIO and therefore, this appeal does not require any adjudication in this Commission. Resultantly, this appeal stands closed as not being prosecuted.
